Student Ethics Award

The BBB Student Ethics Award program recognizes high school students who personify high ethics demonstrated through leadership, community service, and overall personal integrity and academic history. One student will be selected by a panel of judges to receive an award of \$1,700 to an accredited college or university of their choice. The award must be applied within three years of receipt. The funds will be distributed directly to the school upon verification of the student's enrollment. The award must be applied toward school related expenses including; tuition, books, room and/or board, or other related items. The award will be presented to the recipient students in late spring, 2010.

Award Guidelines

Entries for the BBB Student Ethics Award will be reviewed by the Selection Committee. Judges will select the award recipients based on their leadership, contributions to their communities and schools, personal integrity, academic accomplishments, and written essay.

The applicant must be a resident and attend school in British Columbia within the region served by the BBB of Mainland B.C. The applicant must plan to attend an accredited college or university in the United States or Canada. The applicant must be in grade 11 or 12 in high school, and have a desire to continue his/her education. Decisions of the judges are final. Entries should include the completed entry form, and three letters of recommendation: e.g. church, school official, employer, community leader. Each letter should be 300 words or less. Response to essay question should be on one 8.5" x 11 page, single spaced.

Supporting documentation should be typed and submitted on 8.5" x 11" paper. A copy of the transcript will be accepted. Please retain a copy of your completed entry. All submitted entries become the property of the Better Business Bureau of Mainland B.C. and cannot be returned.

Procedure

Deadline

Entries must be postmarked by Monday, March 22, 2010.

Criteria

The criteria for the award includes: Leadership 20%, Community service 20%, Academic 30%, Essay 30%.

Student should demonstrate their commitment to high ethical behavior and provide documentation in the following areas:

1. **Leadership:** Describe any extracurricular activities, work, or school related activities. Include awards/honors or offices held.
2. **Community Service:** Describe activities outside of school and within your community, such as church or special community activities. Include awards/honors or offices held.
3. **Academic:** Enclose a copy of your most recent transcript, describe awards received relating to your academic achievement, and describe your post secondary plans.
4. **Essay:** Character Ethics has been described by modern day and historical leaders as "Character ethics are self-evident, conscience-affirming truths that when acted on consistently, produce virtuous behaviors, such as: compassionate acts, honest answers and just decisions; If character is instilled in leaders, leaders are more likely to act in an ethical way; Right is right, even if everyone is against it; and wrong is wrong, even if everyone is for it".

Now write a concise essay (500 words) on your response to the following: Do you consider yourself a passionate character builder? If so, why is character building so essential to you? How do you propose to motivate and help others to join you as passionate character builders?
